d. Road mileage is allowed only for places not connected by rail. With regards to road mileage, actual rate but not exceeding approved rate under TA rules. Claimant should mention distance between the places. 1) The Payment of TA will be made on production of original Tickets by the trainees. The payment will be made as per CME guidelines.
