Procedure of Application and Submission: A teacher of concern subject working in institution should apply in the enclosed application form duly certified by the head of the institution. Duly filled physical application forms along with a true copy (slf attested) of registration and UG,PGdegree certificate & Aadhar Card should reach the Institute on or before due date specified through post against the programme schedule. Application received after the due date or imcompletely filled application forms will be rejected. The applicants should clearly mention "Application for CME on Rasashastra Evam Bhaishajya Kalpana" on the top of envelope while sending the application form.

The hard copy of the application must reach our Institute by 2nd August 2025 till 5.30pm. The selected candidates will be informed via email by 7th August 2025.

Payment of TA:

- a) All Transaction will be made only by electronic transfer through banks.
- b) No amount will be paid top trainees expect the reimbursement of travelling expenses, that

too on actual basis as per the rules subject to ceiling.

- c) Payment of TA shall be made only at the end of the training programme after obtaining full attendance as per admissibility or actual, whichever is less.
- d) Places where connected by rail, will be reimbursed with actual fare limited to AC 2 tier or actual claim, whichever is less.
- e) Road mileage is allowed only for places not connected by rail. With regards to road mileage, actual rate but not exceeding approved rate under Ta rules. Claimant should mention distance between the places.
- f) The Payment of TA will be made on production of original Tickets by the trainees. The payment will be made as per CME guidelines.

Note:- Please be noted that TATKAL Or DYNAMIC PRICING train tickets will not be reimbursed.

Boarding & Lodging Charge:- Loading & Boarding facilities will be arranged for all the outstation trainees on sharing basis (two in one room). Trainees will be eligible for food expenses if travel made by train/bus on production of bills subject to a maximum of Rs 175/during Journey. No food expenses will be made for travels made by Rajdhani/Shatabdi/Duronto Trains.

Participation Certificate: Full attendance is mandatory for obtaining participation certificate. Participation certificate will be issued at the end of the CME on full attendance only.
